### **Request for Special Consideration Form**

You may be eligible for special consideration if you believe you won't be able to, or you didn't complete, your assessment due to exceptional circumstances beyond your control. The reasons may include:

- a serious medical condition
- loss or bereavement
- family relationship breakdown
- hardship or trauma
- carer responsibilities
- COVID-19 isolation requirements
- obligations to military, jury or emergency services
- other exceptional circumstances.

**You may apply even if you are unsure of your eligibility and the Institute will provide you with an outcome.**

If you meet the eligibility criteria and your application is approved, you'll be granted special consideration.

A successful application may result in one of the following outcomes:

- an extended submission date for an assessment
- an alternative and equivalent form of assessment
- a deferred assessment
- resubmission of a task
- removal of a late penalty
- an exemption from the affected assessment task and a re-weighting of other assessment tasks.

Special consideration cannot change a mark you have already received for an assessment, other than to remove a late penalty.

Once you've been granted special consideration and completed the assessment, your result from that assessment will be final (you can't apply for special consideration again).

- A death notice or certificate and evidence of relationship
- A police report
- A statutory declarations written by you or other relevant people (though we can't accept a statutory declaration in support of a serious medical condition)
- A notification from:
  - Defence services
  - Juries Commissioner's Office
  - Emergency services organisations.

We can hold your application for up to two working days while we wait for your supporting documents. If you do not provide the required documents, your application may be rejected.
